Job Overview – Fish Habitat Restoration and Education Summer Intern

The Fraser River Tidal Marsh Clean-up Field Crew Technician will meaningfully contribute to the health of The Fraser River Estuary in B.C. by supporting fellow technicians in removing debris and garbage that has been deposited along the Fraser River tidal salt-marsh ecosystem. They will support the day-to-day operations of the Field Crew Supervisor, ensuring work is completed in an efficient, effective, and safe manner. Other duties and responsibilities may be added throughout the work term, based on project needs.

Work conditions will primarily be outdoors, in various weather conditions throughout the season, with wildlife encounters and insect activity likely. Work can be physically demanding, and applicants should be capable of and prepared to work on their feet for extended periods, in adverse conditions, and to regularly carry loads up to and exceeding ~22 kg (50lb).

You will be expected to travel within the Lower Mainland to complete the duties of this position. Cities of travel may include Delta, Surrey, Tsawwassen, Richmond, and Ladner. The crew often meets at a common location to carpool in the project truck.

- Remove Debris and garbage from target areas in the Fraser River Estuaries
- Follow data collection procedures to document the waste composition of the identified garbage and debris.
- Conduct nest sweeps during field site entry, adhering to best environmental practices, to identify and protect wildlife habitats.
- Maintain equipment.
- Adhere to safety requirements and protocols in the field.
- Engage in respectful interaction with members of the public, private landowners, representatives of partnering organizations and members of participating First Nations.
- Document clean-up work via photo and video media when possible.
- Other duties as directed by the Field Crew Supervisor and Fish Habitat Restoration and Education Coordinator.
