#### **Firearms Questions**

## 1. Bill C-71, an Act to amend certain Acts and Regulations in relation to firearms, received Royal Assent on June 2019. Do you support repealing Bill C-71? Yes / No

Canada needs a balanced approach to gun legislation. The rules need to ensure that responsible gun owners, hunters, and gun clubs are able to enjoy their sport responsibly, while ensuring that we keep guns out of the hands of criminals and address the very serious issue of gun crime in our cities. ## 4. Why is it necessary to have firearms licensees undergo background checks every five years when the Canadian Police Information Centre computers check you every day?

# **5.** Why is it necessary to revert to the paper issuance of permits to take restricted firearms to gun shows, gunsmiths, and the border if you are allowed to take your restricted firearms to All Approved Shooting Ranges at any time?

Borders, gunsmiths, and gun shows are often not Approved Shooting Ranges. In the case that a border, gunsmith, or gun show may be an Approved Shooting Range then current laws regulating firearms use at, and transportation to those facilities will apply. We do know, however, that the issue of illegal gun-smuggling over the border is a problem, with too many of the guns being transported from the United States ending up in the hands of criminals and gangs. That's why New Democrats will make tackling the issue of gun smuggling and the illegal gun trade a key part of our public safety initiatives.
