Job Overview – FHRE Program Assistant

The BC Wildlife Federation's Fish Habitat Restoration and Education Program (FHRE) is looking for a Program Assistant, anticipated start date is as soon as possible. The Fish Habitat Restoration and Education Program Assistant will work independently under the supervision of the Fish Habitat Restoration and Education Coordinator and the Director of Conservation Stewardship. They will be primarily responsible for supporting the BC Outdoor Access Improvement Project and providing assistance to the Fish Habitat and Education Program workshops and projects. The BC Outdoor Access Improvement Project aims to upgrade trails and fishing docks at selected locations across BC to make them more accessible for people with mobility issues, and increase the number of British Columbians who can enjoy the outdoors. The Fish Habitat and Education Program delivers fish habitat stewardship workshops in communities. This position will primarily work at our office (or a home office), but will include some travel within BC to meet project deliverables. It is anticipated a high portion of their work will focus on the BC Outdoor Access Improvement Project, but opportunities to participate and support other FHREP initiatives will occur throughout the position. The FHRE Program Assistant will be working with a network of lead professionals who work among various levels of government and non-government organizations.

- Support the Outdoor Access Improvement project. Duties include: management of budget, procurement and administration of contract/resources, securement of permits, coordination of volunteers, etc.
- Administer the coordination of contractors and land-owners as per grant agreements regarding upgrades to trails and fishing docks.
- Ensure project deliverables outlined in grant agreements are met.
- Create and distribute a survey/questionnaire for contractors and landowners to complete.
- Administrative duties including preparing external communications (e.g., blog posts, magazine articles, social media posts).
